- Tents and tables will be provided
- Each vendor in the market must be willing to accept EBT/Snap with payment coordinated through the Interfaith Food Shuttle
- Prepared foods, canned goods, meat, poultry, eggs, seafood or dairy must meet NC Department of Agriculture regulations
- Any item listed as organic must have a copy of the certification at the market
- Vendors are highly encouraged to carry liability insurance
- Both WakeMed and the market manager will be held harmless for any liability claims
- Vendor must clean up the area before leaving
- Vendors must abide by parking restrictions as set forth by WakeMed Campus Police
- All produce and at least 75% of the products sold must be grown within 100 miles of the market except in special cases as deemed appropriate by the market manager.
- All vendors must comply with USDA grant regulations and report required information to be eligible for vendor space at the market
